WVBEA MINUTES

The annual meeting of the West Virginia Business Education Association was held July 23, 2012, at 4:00 p.m., in Room 104, at the Charleston Civic Center.

Victoria Mullennex, President Elect, conducted the meeting for Dave Armentout, President, who was unable to attend. She welcomed everyone in attendance, and asked for minutes from the last meeting. Debbie Conrad said she knew someone had done the minutes, but she did not have them.

Kim Britton moved to dismiss the reading of the minutes and the motion was seconded by Crystal Robinson.

Debbie Conrad noted that there was \$9,161.08 in the treasury.

Vicky asked Debbie if she had anything else to share.

Debbie noted that recruitment had increased to 57 members. She also commented that three hours of graduate credit was obtained for some people during the Adobe workshops, and that for the last two years conferences/workshops had been very productive.

Vicky commented that the workshops had been very helpful to continue updates for business teachers. She went on to note that the Executive Committee had met in September at Flatwoods. At that time, it was suggested that the by-laws be changed, so that you can still join at the National level or the State level. It used to be unified in the past. It costs \$10 to join WVBEA. That was what came out of the executive board meeting.

Debbie then went on to explain the difference memberships in WVBEA, SBEA, and ACTE and the cost for these memberships. She noted that the by-laws stated unified member to be WVBEA, ACTE, or NBEA President, Vice President, or Membership Director. She also stated that SBEA would pay for 1 night's lodging and airfare.

Vicky presented a Certificate of Recognition to Debbie for all her hard work and dedication to the organization and turned the program part of the meeting over to Debbie.

Debbie pointed out that Betty Sias had sent us information about free online curriculum for Simulation and Game Development or Information Management concentrations. She noted that Globor; ueekke' [3 [5 titytytythghgh44 oyiiria is now charging for their curriculum, and that perhaps a two day-concentrated workshop for Digital Imaging, Desktop Publishing, and Gaming I/II could be held at Flatwoods. We could tie these classes to the CSSs' and possibly work with IRT. She noted that Denise Stalnaker had a wiki space for this. She went on to say that Flatwoods was wonderful to work with us, and that we could get great rates on Monday-Tuesday stay.

Lorita asked Betty Sias where Business ranked as far at the IRT system was concerned and Betty said we were second in line, that they were currently working with Health.

Betty went on to say that she was concentrating on BCA, Desktop Publishing, Imaging I/II, and Web Design. She said these would be available online from the State web site in PDF files. We will have folders and CSSs' for each class. The IRT will have curriculum that has worked and been brought into one place with projects, websites, and basically getting away from books. In essence, it is a big session in networking for you to have all of our information on one site. It will be a huge folder and you just keep clicking and getting into skill sets.

Lorita noted that Denise Stalnaker has all the information for gaming and Betty told her to talk with Sherri Nash to be sure that they were following the same format as the State was using, so things did not have to be redone. Lorita asked about using Adobe Acrobat so that all files could be compatible.

Betty noted that there are so many resources and this can be a powerful tool for everyone concerned.

Debbie then asked when a convenient Monday-Tuesday date would be for everyone and that she would stop at Flatwoods on her way home to check things out. She mentioned Monday-Tuesday, September 9-10, or 16-17 for a workshop meeting. This would be specific training for business education teachers to gain professional development and have pay—if there are as many as 10 people wanting graduate credit that can be gotten through Marshall for \$180.

The drawing for a door prize was held at this time, and Eva Hinkle was the winner.
